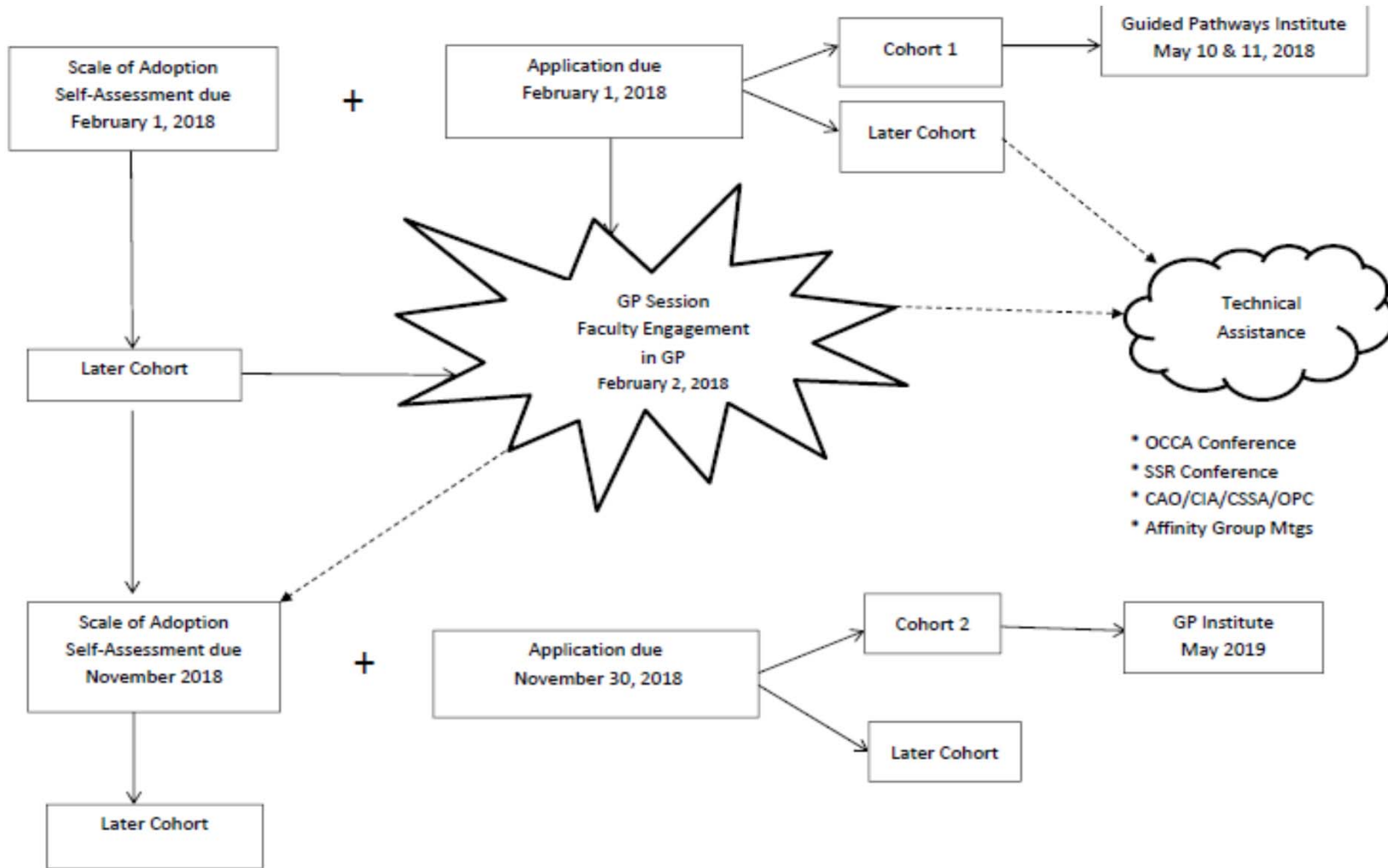

Scale of Adoption Readiness Assessment

Purpose of the Assessment

For colleges:

- ✓ To reflect on current practices and how current reforms and efforts align within the guided pathways framework
- ✓ To assess college-wide understanding of pathways practices
- ✓ To develop a plan for next steps and implementation at scale
- ✓ To see what other colleges are doing, to learn from other colleges

For the Student Success Center:

- ✓ To gather information about colleges activities, practices, & challenges
- ✓ To design coaching, workshops, and technical assistance activities
- ✓ To track colleges' progress over time; re-assess college needs and challenges

Online Scale of Adoption Assessment – Steps

Step 1

- Individuals on campus fill out their own versions
- Only scaling statuses – no comments

Step 2

- College team fills out this “consensus” version together
- College team lead enters information – scaling statuses, progress to date, next steps

Step 3

- Outside facilitator fills out this version during meeting with college team
- Facilitator only changes scaling statuses with college team’s permission
- Comment box for additional notes the facilitator wants to make during the meeting

Pathways

Pathways is the institution's ability to systematically define student pathways, map pathways to student end goals, help students choose a pathway, keep students on a pathway, and ensure that students are learning.

MAPPING PATHWAYS TO STUDENT END GOALS

Every program is well designed to guide and prepare students to enter employment and further education in fields of importance to the college's service area.

Institution is currently not following or planning to follow this practice

Practice is incomplete, inconsistent, informal, and/or optional

Institution is planning to implement the practice at scale

Implementation of the practice is in progress for all students

Practice is implemented at scale—that is, for all degree-seeking students
