ENTRANCE REQUIREMENTS

1. **Applicant must** be 18 years of age prior to starting the **PARAMEDIC** program
2. **Applicant must** have an accumulative GPA of 2.00 or higher.
3. **Applicant must have completed MTH 095, WR 121, SP 111, PSY 101, EMS 151, EMS 152, EMS 180, ES 101, ES 113, MED 111 and BI 231-233** with a grade of C or above, by the end of Summer term **2023**. **Applicants must submit a copy of their unofficial transcripts.**

Students who are **NOT** current UCC students, must submit official transcripts from all colleges attended. Please address transcripts to:

4. **Applicant must** provide documentation of Oregon EMT state licensure or have completed EMT with a grade of a C or better. ***Please note:*** Current EMT students making satisfactory progress may apply.
Accepted applicants must possess an Oregon EMT, Advanced EMT, or EMT Intermediate license *prior* to first day of paramedic class.
5. The following functional abilities are essential for success in UCC's EMS Paramedic Program: ***Gross Motor Skills, Fine Motor Skills, Physical Endurance, Physical Strength, Mobility, Hearing, Visual, Tactile, Smell, Reading, Arithmetic, Emotional Stability, Analytical Thinking, Critical Thinking Skills, Interpersonal Skills, and Communication Skills.*** If you have questions about your ability to meet the program requirements, please contact the UCC EMS Department at 541-440-4662.

6. CRIMINAL BACKGROUND CHECK

All students must submit, at their own expense, a criminal background check by visiting www.mystudentcheck.com

and selecting: **Umpqua Community College-Background Check Only**. The background check is required for incoming students prior to **09/22/2023**. It is preferred that the background check be completed prior to the incoming student registering for class. Background checks from other agencies will not be allowed as substitution.

As a result of the background search, students with felony convictions will only be considered on a case-by-case basis. Potential students with felony convictions involving crimes concerning arson, perjury, domestic violence, child abuse, elderly abuse, or patient misconduct/abuse, will not be permitted in the EMS Program. DRUG SCREENING

All students must submit, at their own expense, a drug screening by visiting OccuHealth at 2570 NW Edenbower Blvd, Roseburg, OR 97471. The drug screen is required for incoming students prior to **09/22/2023**. Drug screenings from other agencies will not be allowed as substitution. As a result of this screening, students with any positive results will not be permitted in the EMS Program. Students are granted an appeal process by contacting the EMS Program Director.

PHYSICAL AGILITY ASSESSMENT

All students must submit, at their own expense, a physical exam within the last 12 months. Record of physical agility may be accepted from an affiliated agency, or students may receive a physical at OccuHealth mentioned above. Proof of physical must be submitted before **09/22/2023**.

It is important that these requirements are completed in a timely and accurate manner in order to ensure final acceptance into the program.
