## S130/S190/L180 Session: 3-part Entry Level Firefighting Skills

4 day \$199.00

- S130 - This course is designed to provide entry level firefighters skills. Field time is encouraged, and many of the units are set up so they can be taught in either the classroom or the field. The field exercise for Unit 12 is required. A version of L-180, Human Factors on the Fire line, has been included as part of this course.
- S190 - This course provides instruction in the primary factors affecting the start and spread of wildfire and recognition of potentially hazardous situations. This course is typically taught in conjunction with or prior to "NWCG S-130, Firefighter Training.
- The L-180 The course is designed for entry-level operational personnel; however, this course also applies to all wildland fire service personnel, including non-operational personnel. At the end of the course, students will be able to practice decision-making skills, hazard identification, decision-making, and team cohesion.

### Course Objectives/Outcomes:

- Explain what the LCES (Lookouts, Communications, Escape Routes, and Safety Zones) system is and how it relates to the Standard Firefighting Orders.
- Construct fireline to required standards using various methods.
- Strengthen, reinforce, and use holding actions on a fireline.
- Extinguish the fire with or without the use of water.
- Complete assigned tasks in a safe and efficient manner.
- Describe the purpose of the Standard Firefighting Orders and Watch Out Situations.
- Describe the various communication methods and tools used for collecting, producing, and distributing information.
- Describe the standards, tools and equipment, and various methods used in fireline construction.

## RT130 Session: Annual Fireline Safety Refresher Training

RT 130-Annual Fire line Safety Refresher Training should be designed to provide up to date fire line safety information to employees holding Incident Command System qualifications requiring this training per the PMS 310-1, Wildland Fire Qualification System Guide.

### Course Objectives/Outcomes:

There are four core components to the Annual Refresher Training which include:

- **Entrapment Avoidance** – Use training and reference materials to study the risk management process as identified in the Incident Response Pocket Guide (IRPG) as appropriate to participants, e.g., LCES, Standard Firefighting Orders, Watch Out Situations, Wildfire Decision Support System direction, Fire Management Plan priorities.
- **Current Issues** – Review and discuss current topics which could be based on the new modules or areas of concern identified by your agency or geographic area. Review forecasts and assessments for the upcoming fire season and discuss implications for firefighter safety.
- **Fire Shelter** – Review and discuss last resort survival including escape and shelter deployment site selection. Conduct “hands-on” fire shelter inspections. Practice shelter deployments in applicable crew/module configurations. Wearing fireline personal protective equipment during fire shelter practice can enhance the learning experience for students.
- **Other Hazards and Safety Issues** – Choose additional hazard and safety subjects, which may include SAFENET, current safety alerts, site/unit specific safety issues and hazards.
